Show Hours:

Friday: 1-6pm

Saturday: 9am-5pm

Acceptable Items:

We strive to present the best show possible for both vendors and customers and request that a majority of items for sale be hand-crafted. Flea market and garage sales items are not permitted. At the discretion of the Show Chair, vendors with commercially produced items or direct sales will be placed in outside booths away from hand-crafted booths. The Show Chair also reserves the right to request the removal of any objectionable item(s).

Booth Locations:

Thirty-eight spaces are available under a covered pavilion on a first request/first paid basis. Inside booth space is extremely limited. **Check with Show Chair before applying for inside space.**

Set-up:

Set-up is on Friday from 9am-noon. There is no security on Friday night. Outside vendors must provide their own tables and chairs. Inside booths will have one table and two chairs provided.

Parking:

All vendor vehicles and trailers are to be removed from the show area by noon on Friday. Vendors may park in the adjacent lot only. No vehicles or trailers may be parked on the streets surrounding the show grounds after the show opens on Friday.

Tax:

The State requires that all vendors have a sales and use tax permit. If you do not have a tax permit, you may pay your taxes through KHAC. Please see the Show Chair for information on how to do this. (State Tax Code 96-211)

Fees:

Booth fees are \$40 for inside, \$30 for covered outside or canopy space. Electricity is an additional \$5. Fees are non-refundable after acceptance. **Inside space is very limited, call before applying.**
