Show Hours:

Saturday, November 12, 2022, 9am-3pm

Acceptable Items:

We strive to present the best show possible for both vendors and customers, and request that the majority of items be hand-crafted. Flea market and garage sale items are not permitted. Firearms and/or ammunition are not permitted. Applications with commercially produced or direct sales items will be reviewed by the Show Committee for acceptance. The Show Chair reserves the right to request the removal of any objectionable items.

Fees:

Booth fees are \$30 each for outside covered or canopy spaces. Electricity is an additional \$5. Fees are non-refundable after acceptance. Please, NO space heaters; our electrical system cannot handle the additional load.

Booth Locations:

Thirty-eight spaces are available under a covered pavilion on a first request/first paid basis. Canopy space is also available. All spaces are approximately 10'x10'.

Set-up:

Set-up is Saturday starting at 7am. Vendors must provide their own tables, chairs and display equipment.

Parking:

Please unload and move your vehicle; then set up your booth. All vehicles and trailers are to be removed from the show area by 8:30am. Vendors should park in the lot adjacent to the show grounds. No vehicles or trailers are permitted on the show grounds during event hours. Vendor vehicles may return to the show grounds at 3:00pm.

Tax:

The Texas State Comptrollers Office requires that all vendors collect sales tax. If you do not have a sales tax permit, please see the Show Chair. Kingsland sales tax rate is six and one-quarter percent (6-1/4%, .0625). (State Tax Code 96-211)
